families and 4,576 family members of seriously ill children. In
addition to providing a place to sleep in one of our 36 guestrooms, we
offered families laundry facilities, meals prepared by volunteers, and
more. The average stay at Ronald McDonald House was 6 days, and 414
families stayed one week or longer.

Our Ronald McDonald Family Rooms take the concept of a freestanding
Ronald McDonald House, then moves it inside the hospital. In 2018, the

Hospital, Norton Women & Children's Hospital and Frazier Rehab
Institute.
