Our House

Within walking distance of Louisville's downtown hospitals, Kentuckiana's Ronald McDonald House has 36 rooms staffed 24 hours a day, 365 days a year. Our private bedrooms, comfortable living rooms, vibrant play areas and fully-stocked kitchens offer a "home away from home" for families of seriously ill children.

Volunteers from our Adopt-A-Meal program offer a warm meal nearly every day at 6 p.m. and brunch on Saturdays and Sundays for the families staying with us. Volunteers also prepare guest rooms, bake goodies and treats, and help us make our House a home. For

three decades, we have provided warmth, comfort and security for more than 30,000 families of seriously ill children.

Our Ronald McDonald House opened its doors in 1984 with 19 guest rooms. In 2003, the House grew to 29 guest rooms, increasing our overall capacity by more than 50 percent.

In June 2007, Kosair Charities provided a \$1.25 million grant to Ronald McDonald House Charities of Kentuckiana, allowing us to expand our facility in 2009 to our current capacity of 36 guest rooms.

Who Can Stay at our House?

- Families with children ages 21 or younger who are receiving medical care in the Louisville area.
- A qualifying family must live outside of Jefferson County, Ky.; as well as Clark and Floyd counties in Indiana.
- Each family must be referred by a physician, nurse or social worker from the hospital where the child is being treated.

We ask guest families to contribute only \$15 a day to help cover some of the costs associated with their stay. However, no one is turned away if they are unable to pay.





After years of trying to conceive a child, we found out we were pregnant! The summer of 2013 was wonderful; at every check-up my sweet baby boy was healthy and growing. He was expected to arrive on March 5th, and it couldn't get here soon enough, but then it did. On Sunday, December 15th I went to bed with horrible pains in my back. By Monday morning we headed out to our local hospital in Glasgow, KY on the advice of our doctor. We stayed overnight doing testing and Tuesday morning I was sent to Norton's, Downtown Louisville with preeclampsia. Our lives had just turned to an unknown tomorrow.

My husband, Whitney, was able to be by my side the entire time and that helped, but we were both scared to death. They managed to hold Levi in until that Friday, but then our stats began to plummet. Here we were in a new town, at a hospital two hours away

from our family, and preparing to deliver our 29 week old son. Miraculously, Levi was born healthy weighing in at 2lb 11ozs. Levi was then transferred to the NICU at Kosair Children's Hospital where we would start our two month journey to grow our baby boy.

We were still scared to death of what lie ahead of us knowing we lived so far away. How were we going to afford a hotel, meals, and gas to drive back and forth from home every day? That's when our prayers were answered and our awesome nurses in the NICU suggested we call the Ronald McDonald House. We had heard of this "house" for years. We always threw our extra change in the donation box at McDonald's, but never thought that this house would one day be our home.

After being discharged from Norton's on Christmas Day, we walked one block away to the RMH not knowing what to expect. Let me just say we were blown away as soon as we stepped inside. Tiffany introduced us to staff and volunteers and gave us a tour. From that moment, our stress was relieved knowing that the people in that house had just welcomed us into a place we could call home. Over the next two months we met many amazing people. People that we talked to, ate our meals with, prayed with, and even cried with. Many of whom we still talk to today.

Without the RMH, it would not have been possible for Whitney and me to have been by Levi's side every day. It takes a lot to run the house and without the professional staff, the volunteers, (that even showed up on snowy days) and the donors we would have been lost. Levi has had a minor surgery since we left, but is doing great now! The McGuire family will forever remember the impact the Ronald McDonald House of Kentuckiana played in our lives.







Our Ronald McDonald Family Rooms

Norton Women's & Kosair Children's Hospital St. Matthews

This Ronald McDonald Family Room, located in the Plaza 1 Building on the 2nd floor, serves families with a baby in the Neonatal Intensive Care Unit. There are four private sleeping rooms, Internet/email access, restrooms with shower facilities, a lactation room, a kitchenette stocked with snacks, a living room and a laundry room. We are always seeking volunteers to help us at this location.

Kosair Children's Hospital

Located within the oncology unit, this Ronald McDonald Family Room serves families with a child receiving a bone marrow transplant. For infection control purposes, this location is away from other waiting rooms and has sleeping quarters for up to three families at a time, a restroom with a shower facility, a kitchenette and a living room.

Frazier Rehab Institute

Located on the pediatric floor of Frazier, this Ronald McDonald Family Room is a relaxing resting spot for families who are not allowed to be present while their child receives rehabilitation therapy. We offer access to a living room with cable TV, a restroom with a shower and an eating area stocked with snacks.






While our second daughter was in the NICU the Ronald McDonald Family Room at Norton Women's & Kosair Children's Hospital-St. Matthews became a second home. Vivian was born at 23 weeks weighing 1 lb 8 oz. It was very touch and go for a long time... we were not sure if she was going to survive. Being able to stay so close to our baby, without having to pay for a hotel, while she fought for her life was a huge weight off our shoulders. There were times that I didn't run home for days and the amenities the RMFR made available made it much easier to take care of myself. Even on days when we chose not to stay the night the living room, laundry room,

and showers were available to us. There were books about preemies, the NICU and stories of NICU graduates to help support you and give you hope. The lactation room was also very convenient and they even provided a pump. It was also nice to have the opportunity to meet other NICU parents staying there and to offer support and to talk about the ups and downs of having a sick little one. Our sweet miracle stayed 94 days in the NICU before going home healthy. I know that part of what got us through the stress of juggling a toddler at home with a newborn in the NICU was having this home away from home available to us.




Scholarship Recipients

A Closer Look at a 2014 Grant Recipient

Upside Therapeutic Riding, Inc. provides physical, occupational and speech therapy services to special needs children using hippotherapy, the movement of the horse, as a treatment strategy. Upside provides services to children with diagnoses such as Down Syndrome, Autism, Cerebral Palsy, and Fetal Alcohol Syndrome.

Upside began providing services at Rock Creek Riding and Seneca Park in June 2013. The facility where services had been provided in their first three years was foreclosed in March 2013. Upside's horses are boarded in Finchville, Kentucky and are trailered back and forth three times a week to Rock Creek Riding Club and Seneca Park.

The number of children to be served in 2014 had doubled from the previous year.



Upside had approximately 30 children scheduled for services in the spring and summer of 2014. Upside was in need of a larger horse trailer in order to transport enough horses for therapy. In June 2014, a new 4 horse trailer was purchased through the generous support of our community partners like Ronald McDonald House Charities of Kentuckiana.

RMHCK also purchased one of Upside's most beloved therapy horses, Topper, in 2009. Topper is a ten year old Haflinger

draft pony. Topper is about five feet tall and weighs 860 pounds. He has a double white flowing mane and a white tail that touches the ground. Topper has taken care of hundreds of children over the past six years. He is confident, calm, trustworthy and steadfast. This summer vill be making home visits to pe patients as well as providing services. Thank you RMHO. To making it possible for Upside to own this incredible therapy horse. Topper has truly made a difference in the lives of so many children.


